



ORTHOAXIS, LLC SWEEPSTAKES OFFICIAL RULES

1. **NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.**

2. **Entry Period.** The OrthoAxis, LLC Sweepstakes (“**Sweepstakes**”) is a monthly promotion (referred to hereafter as “**Monthly Entry Period**”). Each Monthly Entry Period begins at 12:00 a.m. CST on the first day of the month and ends at 11:59 p.m. CST on the last day of the same month. A monthly random drawing will be conducted from all eligible entries received per Monthly Entry Period.

3. **Eligibility.** Open to residents of the 50 United States and D.C., 18 years of age and older at time of entry, except for employees of OrthoAxis, LLC (“**OrthoAxis**”), its affiliates, subsidiaries, and agencies (collectively “**Promotion Parties**”), and members of their immediate family or persons living in the same household. Void where prohibited. All federal, state and local laws and regulations apply.

4. **How to Enter.** There are two (2) methods of entry—the Online Method of Entry and the Mail-In Method of Entry.

(a) **Online Method of Entry.** During each Monthly Entry Period, eligible participants can enter the Sweepstakes by following these steps: i) visit <https://www.doortoaxis.com/index.html> (“**Website**”) and sign in to your account or create an account if you are not a registered member and are eligible to be a registered member; and ii) rate products, provide a product review, write a review on a representative, use the forum to comment or post, or contact a representative through the Website (each, an “**Online Entry**”). Individuals that are eligible to create an account and become a registered member are limited to orthopedic physicians, residents, orthopedic service providers, and orthopedic health care facilities ordering department personnel. After successfully submitting an Online Entry, you will automatically be entered into the Sweepstakes unless you notify OrthoAxis of your desire to opt-out of the Sweepstakes. You may opt-out of the Sweepstakes by sending an e-mail to info@doortoaxis.com expressing your desire to opt out. In doing so, please include a reference to opting-out of the Sweepstakes in the subject line of the opt-out e-mail. Individuals that are not eligible to create an account and become a registered member may still submit an Online Entry by sending an e-mail to info@doortoaxis.com, with a subject line of “Online Sweepstakes Entry”, and providing your first and last name, street address, phone number, and e-mail address. You may only make an Online Entry utilizing this method once per day, per e-mail address. Inappropriate comments in the product review will be disqualified at the sole discretion of OrthoAxis. To be eligible for a given monthly random drawing, your Online Entry(ies) must be received within the applicable Monthly Entry Period.

(b) **Mail-In Method of Entry.** To enter the Sweepstakes without utilizing an Online Entry, you may submit a mail-in entry. To enter via this method, handwrite your first and last name, street address, phone number and e-mail address on a piece of paper, insert the paper

in a #10 envelope and mail your entry via first-class mail to: OrthoAxis, LLC Sweepstakes, OrthoAxis, LLC, P.O. Box 47, Chili, WI 54420 (“**Mail-In Entry**”). Each Mail-In Entry must be mailed separately. OrthoAxis is not responsible for late, lost, damaged, illegible or postage-due mail. To be eligible for a given monthly random drawing, your Mail-In Entry(ies) must be postmarked during the applicable Monthly Entry Period and received within seven (7) days.

(c) Online Entry and Mail-In Entry are collectively referred to herein as “**Entry(ies)**”. All eligible monthly Entries received will not roll over to the subsequent Monthly Entry Period. If no eligible entry is received in a given Monthly Entry Period, that monthly prize will not be awarded. Entries using macro, robotic, script or other forms of automatic entry will be disqualified. OrthoAxis may prohibit an entrant from participating in the Sweepstakes or winning a prize if, in its sole discretion, it determines that said entrant is attempting to undermine the legitimate operation of the Sweepstakes by cheating, deceiving or using other unfair playing practices.

5. **Drawing.** A random drawing will be conducted on or about the 15th of each month by OrthoAxis to select the winner from among all eligible Entries received. Odds of winning depend on the number of Entries received. Each winner will be notified by e-mail and must sign and return any required form, if any, within five (5) days of the date notice is sent or such other date set by OrthoAxis. Failure to respond within the applicable time period will result in forfeiture of prize and OrthoAxis shall have the option to award the prize to an alternate winner. The return of any prize notification or prize as undeliverable may result in disqualification and an alternate winner may be selected. All income taxes resulting from acceptance of prize are the responsibility of winner.
